New Emergency Management Responsibilities for Local Governments (UBCM - Sep 15, 2023)

This fall, the Province will introduce new emergency management legislation, including new responsibilities for local governments. The **Ministry of Emergency Management and Climate Readiness (EMCR)** has outlined key policy shifts in a <u>technical paper</u> with a focus on the impact on local governments.

UBCM has been consulting with the Province on this legislation and advocated for the supports necessary for local governments to fulfil their new responsibilities - specifically long-term funding and capacity-building framework.

The new legislation has been designed to address many recent challenges, including the increasing frequency and severity of climate-related disasters and emergencies. It also acknowledges and incorporates several new principles and provincial commitments. One of these in particular is a focus on all four phases of emergency management (mitigation, preparedness, response and recovery) as well as the role of climate change. (Where is the Emergency Management Plan for Saltair – which is NOT the slope stability bylaw.... Maybe we should generate our own!)

Ladysmith & CVRD announce completion of Stocking Lake Dam infrastructure upgrades

According to a news release from the town, the project scope for the completed work involved addressing a leak that was identified over the winter and further strengthening the dam itself.

The contractor retained by the town removed material from the dam on the downstream side and laid rock riprap to further reinforce the structure and to address the leak, debris was removed from the spillway channel and a water barrier was installed and topped with rock.

"The town and CVRD continue to explore funding opportunities from senior levels of government for the dam replacement," noted the release, adding that a preliminary design for a new dam was completed in 2021. Ladysmith utilities staff inspect the dam weekly to ensure that it is functioning properly.

BC Gov Patting Itself on the Back -

They're removing single-use plastic supports in their seedling planting initiatives. See the website here for the full story: https://news.gov.bc.ca/releases/2023FOR0061-001531

The Province will remove single-use plastic wraps for all pine, spruce and cedar tree seedlings. In 2024, the plastic-free tree seedlings will support reforestation projects in every corner of the province. This decision follows a test in the Cariboo where they found the plastic supports weren't required. They are very pleased with themselves: "Removing one single-use plastic has a positive impact on our environment, but removing three million single-use plastics per year is a massive achievement. By 2030, it is estimated that as many as 18 million single-use plastic seedling wraps will be eliminated within B.C. by the wider forestry sector. The removal of single-use plastic is part of the Province's CleanBC goals to reduce plastic waste and create a sustainable, circular economy that fights climate change."

Apparently they're going to use recycled wood waste to produce the supports for the seedlings – makes perfect sense.

New Regional Recreation Commissions –

Following a successful referendum in 2022 to implement a usage-based funding model for Cowichan's nine regionally significant recreation facilities, the CVRD established a new Commission structure for governance of those facilities. Four new sub-regional Commissions have now been established. The new commissions will have orientation meetings in late October 2023, and be in a position to review 2024 facility budgets in November 2023.

Cowichan North Recreation Commission will provide governance for Fuller Lake Arena and Frank Jameson Community Centre. Commissioners are:



This Winter May Not Replenish Our Water

The Weather Network "Fall Forecast" does not bode well for our reservoirs, lakes and rivers. Maybe we should be limiting our water usage for the entire fall / winter season until the actuals start to come in. According to the Weather Network (check their website under the "News" header): "the wet pattern during the final week of September is not a sign of what is to come for the rest of the season. We expect that a mild and dry pattern will return and be the dominant pattern for the fall season. Despite the forecast for drier conditions overall, we are concerned about the risk of a couple of high-impact storms before the end of the season. The widespread warmer-than-normal ocean water temperature in the north Pacific supports a risk for excessive rain with any strong storms that impact the region."







If the El Nino effect comes through as expected (although temporary fluctuations and differences are possible), this will be (again) precedent-setting and puts the globe into uncharted territory as far as global warming is concerned. Even the very deep ocean is being affected by this event and its impacts may not dissipate. Not only will the duration of this El Niño have lasting effects on northern hemisphere weather — it's also the fact that it could grow into one of the strongest events on record — 80% confidence at the US National Oceanic and Atmospheric Administration in their prediction.

- Shape more place-specific, well-designed and livable complete communities, and area-specific objectives and policy to address daily needs, infrastructure, transportation and housing.
- Preserve and enhance the qualities that people love and cherish about their community.

Each of the local area plans will be supported by a Complete Community Assessment.


INFO FROM THE SALTAIR COMMUNITY CENTRE:
